THESE CAMPS SERVED YOUTH IN KINDERGARTEN THROUGH AGE 22 AND WE SERVED 110 KIDS. THESE CAMPS PROVIDE THE FOUNDATION FOR DIABETES MANAGEMENT AND EDUCATION IN ORDER FOR THE YOUTH TO LEARN HOW TO LIVE A HEALTHY LIFESTYLE AND BECOME SELF-RELIANT. IN ADDITION, IT IS A TIME FOR THE CAMPERS, COUNSELORS AND STAFF TO CONNECT WITH EACH OTHER AND CREATE AN ON-GOING SUPPORT NETWORK. EACH CAMP IS STAFFED WITH MEDICAL PERSONNEL AND VOLUNTEERS. MOST OF THE COUNSELORS ARE DYS CAMP ALUMNI AND LIVE WITH TYPE 1 DIABETES. THE ALUMNI LOVE TO GIVE BACK TO DYS AND MENTOR THE CAMPERS. WHILE DYS COSTS TO ADMINISTER CAMP ARE EXTENSIVE DUE TO THE LEVEL OF MEDICAL EXPERTISE AND NECESSARY SUPPLIES, WE SUBSIDIZE A LARGE PORTION OF THE CAMPERS' FEES WITH SCHOLARSHIPS.

DYS PROGRAMS ARE DESIGNED TO BRING FAMILIES TOGETHER SO THEY CAN HAVE FUN WITH EACH OTHER, LEARN FROM EACH OTHER AND UNDERSTAND THEY ARE NOT ALONE IN THE CHALLENGES OF MANAGING TYPE 1 DIABETES. IN 2021, 642 PEOPLE PARTICIPATED IN DYS PROGRAMS.
